The Resolution and Order are as follows:


**WHREAS**, the laws of the State of Texas provide that on the 4th day of May 2024, there shall elect the following Officials for this City:

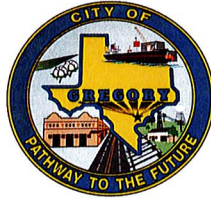
