### **PUBLIC SERVICE ANNOUNCEMENT: FAIR HOUSING, IT'S THE LAW**

To promote fair housing practices, the County of San Patricio encourages potential homeowners and renters to be aware of their rights under the National Fair Housing Law. Title VIII of the Civil Rights Act of 1968, as amended, prohibits discrimination against any person on the basis of race, color, religion, sex, disability, familial status or national origin in the sale or rental of units in the housing market. ### **POLICY OF NONDISCRIMINATION ON THE BASIS OF DISABILITY**

These procedures outline the steps for a citizen to follow if he/she wishes to file a complaint or grievance about GLO CDBG-MIT activities. A person who has a complaint or grievance about any services or activities with respect to the GLO CDBG-MIT project may, during regular business hours, submit such complaint or grievance, in writing to David Krebs at the County of San Patricio County Courthouse located at **400 West Sinton Street, Suite 109, Sinton, Texas 78387**, or by calling **(361) 364 - 9301**. The County of San Patricio will make every effort to respond fully to such complaints or grievances within fifteen (15) working days where practicable after receipt of the original complaint or grievance.
