In an attempt to contain the spread of the Coronavirus, the San Patricio County Court at Law has implemented Infectious Disease Protocols. At this time, to limit the in-person contacts, County Court at Law will be resetting all non-essential civil, criminal, probate and juvenile matters currently set for dates between March 19, 2020 – April 2, 2020. Additionally, the Court will be resetting all bond returnables currently set for the dates of March 23rd, March 30th, April 14th, April 20th, and April 27, 2020. Defendant and Attorney appearances are hereby waived for your current court settings. Reset notices will follow via regular mail. Defendants, please remember failure to appear at your rescheduled court date will result in a warrant being issued for your arrest. Probate and juvenile matters that need hearings will be conducted via Lifesize video conference only. All civil matters that do not need a hearing will be reset on a case-by-case basis, with the parties contacting the Court for settings.

*All cases involving inmates shall be brought to the attention of the Court so that immediate action may be taken.

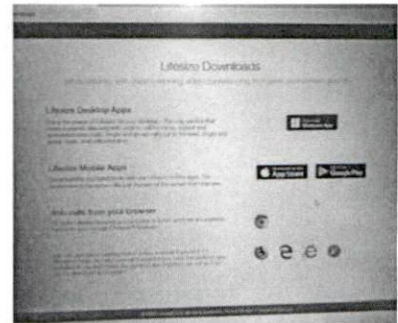
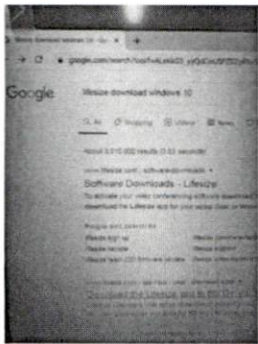

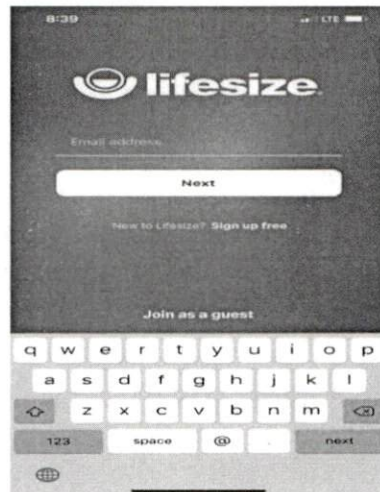
Lifeseize Video Conference

In an attempt to contain the spread of the Coronavirus, the San Patricio County Court at Law has implemented Infectious Disease Protocols. The Court will be using the lifeseize video conferencing system to conduct most court business. Please see below the information to allow you to access the system and appear in court by way of video conferencing.

Desktop: If using a desktop, google “lifeseize software download” which should direct you to a page where you can then download the lifeseize desktop app. It is the one on the right hand column that says lifeseize app (download app). It should then direct you to a page where the top application allows you to download via windows, and the next down via apple device. Once you have downloaded the desk top app, you should be able to follow the directions below for smart device. Sign in as a guest, you do not need to enter an email address. Remember, you don’t need an account, just sign-in as a guest, enter your first name, and enter extension 700150 to call the court.



Smart Device: If using a cell phone, ipad, or other smart device, you need to download the lifeseize app (see image below). Once you have the app, click on join as a guest on the bottom of the screen, enter your name and extension 700150, to call the Court.



Join as a guest on the bottom of the screen. Enter your name _____ (first name only) ; Enter the extension 700150 It will then dial the Court lifeseize video conferencing system and will be answered in the courtroom.
