

**NOTICE OF BOND ELECTION**

**STATE OF TEXAS** §  
**COUNTY OF NUECES** §  
**CORPUS CHRISTI INDEPENDENT SCHOOL DISTRICT** §

*WHEREAS*, the Board of Trustees of the Corpus Christi Independent School District (the “District”) deems it advisable to call the election hereinafter ordered; and

*WHEREAS*, it is hereby officially found and determined that the meeting at which this Order was passed was open to the public, and public notice of the time, place, and purpose of said meeting was given, all as required by Chapter 551, Texas Government Code.

*WHEREAS*, the Board of Trustees finds and determines that all facilities to be acquired, constructed, renovated, improved or equipped pursuant to the Proposition herein will be used predominantly for required classroom instruction and essential administrative operations for faculty and staff.

***THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE CORPUS CHRISTI INDEPENDENT SCHOOL DISTRICT THAT:***

- 1. TIME AND DATE.** A bond election (the “Election”) shall be held in the District between the hours of 7:00 A.M. and 7:00 P.M. on Tuesday, November 8, 2022, a uniform election date as established by Section 41.001(a) of the Texas Election Code, as amended.
- 2. OFFICIAL PROPOSITIONS.** At said election the following PROPOSITIONS shall be submitted to the qualified voters of the District in accordance with law:

**PROPOSITION**

“Shall the Board of Trustees of Corpus Christi Independent School District be authorized to issue and sell bonds of the District in the aggregate principal amount of \$220,000,000 for the purpose of acquiring, constructing, renovating, and equipping school buildings in the District and the purchase of the necessary sites for school buildings; and shall the Board of Trustees of the District be authorized to levy and pledge, assess and cause to be assessed and collected annually ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds as the same become due and to pay the costs of any credit agreements executed or authorized in anticipation of, in relation to or in connection with the bonds; with said bonds to be issued in one or more series or issues, to mature serially or otherwise not more than 40 years from their date, and to bear interest at such rate or rates not to exceed the limit prescribed by law at the time of issuance, all as the Board of Trustees shall in its discretion determine?”

3. **CONDUCT OF THE ELECTION.** The Election shall be conducted in accordance with the Texas Election Code in Nueces County under the jurisdiction of the Nueces County Election Administrator. The Election shall be held at the polling places for the election precincts, each of which is composed of the territory included in certain Nueces County election precincts as designated by the Nueces County Election Administrator. The election precincts and polling places as designated by the Nueces County Election Administrator are hereby adopted as the election precincts and polling places of the District as shown on Exhibit "A", which Exhibit "A" which may be revised from time to time by the Nueces County Election Administrator, and when final shall be attached hereto and made a part hereof for all purposes as if copied herein verbatim.

4. **PRESIDING JUDGES.** The District will hereafter contract with the Nueces County Clerk's Office to conduct this election, which contract will be in the form of an Elections Services Contract to be hereafter approved by the Board of Trustees of the District under the authority of Section 31.092 of the Texas Election Code. The Nueces County Elections Administrator is authorized and directed by the District to designate Early Voting Ballot Board and the Presiding Judge and Alternate Presiding Judge for each polling place by a supplement to the Order. The election officers consisting of a Presiding Judge and an Alternate Presiding Judge, to serve as election officers of this election who shall possess the qualifications for election officers as provided by law, hereby appointed by the Board of Trustees of the District shall be those election officers appointed by the Nueces County Clerk for the proper conduct of said election.

5. **ELECTION CLERKS.** The Presiding Judge of each polling place shall appoint not less than two nor more than six qualified election clerks to serve and assist in conducting said election; provided that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks; and provided further that it shall be the duty of each election officer to appoint a person capable of rendering oral aid in the Spanish language to any voter desiring such aid at the polling place on the day of said election and during the early voting period.

6. **Early Voting.** (a.) *Early Voting by Mail.* Electors may cast their early vote by *mail* and shall be conducted by paper ballot. The early voting clerk's mailing address to which ballot applications and ballots voted by mail shall be sent to is as follows:

(b.) *Early Voting Polling Places.* Early voting by *personal appearance* shall be conducted at the locations on the days and at the times designated by the Nueces County Clerks Court, in accordance with applicable law, which shall include the following, as the main early voting location:

and such other locations as so designated by the Nueces County Clerk, which locations as so designated shall be contained in a list marked Exhibit “B,” which Exhibit “B” shall be attached hereto and made a part hereof for all purposes as if copied herein verbatim, and which locations are hereby designated by the Board of Trustees of the District for such purposes, and which Exhibit “B,” as hereby approved, is authorized to be changed, revised, or amended as such locations designated by the Nueces County Clerk are changed, revised or amended, from time to time in accordance with applicable law.

(c.) Temporary Branch Early Voting Polling Places. Temporary branch early voting locations, dates and times if any, as may be designated or approved by the Nueces County Elections Administrator, are hereby designated to be those set forth on the instrument attached hereto and marked as Exhibit C, which instrument shall be attached hereto and shall be incorporated herein and made a part hereof for all purposes.

**7. EARLY VOTING BALLOT BOARD.** An Early Voting Ballot Board is hereby created to process early voting results. The Nueces County Clerk is hereby authorized to designate a Presiding Judge, who is hereby appointed by the Board of Trustees. The person appointed the Presiding Judge of the Early Voting Ballot Board after being duly designated shall be listed on the Exhibit “B” which shall be attached hereto. The presiding judge shall appoint at least two other members of the Early Voting Ballot Board. The Early Voting Clerk shall determine whether the Early Voting Ballot Board shall be assisted by a signature verification committee, in accordance with Section 87.027 of the Texas Election Code, and shall act accordingly.

**8. VOTING SYSTEMS.** Voting machines (including voting machines commonly called “Direct Recording Equipment”) shall be used for the conduct of the election on Election Day and for early voting by personal appearance; provided, however, that if the use of such voting machines is not practicable, then in that event, electronic voting devices may be used in conducting the election on Election Day and for early voting by personal appearance; provided, however, in the event the use of such electronic devices is not practicable, the election may be conducted on election day and for early voting by personal appearance by the use of paper ballots. Early voting by mail shall be conducted by paper ballot. The District shall utilize a Central Counting Station, as provided by Section 127.000, *et seq.*, as amended, Texas Election Code, to process the results of the early voting ballots. Diane Munguia is hereby designated as Counting Station Manager and Presiding Judge of such Central Counting Station. Eric Gutierrez is hereby appointed as Tabulation supervisor of such Central Counting Station. The Nueces County Clerk, for and on behalf of the District, will publish notice and conduct testing on the automatic tabulation equipment relating to the Central Counting Station and conduct instruction for the officials and clerks for the Central Counting Station in accordance with the provisions of the Texas Election Code.

**9. ELECTORS.** All resident, qualified electors of the District shall be entitled to vote at said election.

**10. FORM OF BALLOTS.** The official ballots for said election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote “FOR” or “AGAINST” the aforesaid PROPOSITION with the ballots to contain such provisions,

markings, and language as required by law, and with such PROPOSITION to be expressed substantially as follows:

PROPOSITION

- FOR             THE ISSUANCE OF \$220,000,000 OF SCHOOL BUILDING BONDS FOR ACQUIRING, CONSTRUCTING, RENOVATING, AND EQUIPPING SCHOOL BUILDINGS IN THE DISTRICT AND THE PURCHASE OF THE NECESSARY SITES FOR SCHOOL BUILDINGS, AND THE LEVYING OF A TAX, SUFFICIENT WITHOUT LIMIT AS TO RATE OR AMOUNT, TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS AND TO PAY THE COSTS OF ANY CREDIT AGREEMENTS EXECUTED OR AUTHORIZED IN ANTICIPATION OF, IN RELATION TO, OR IN CONNECTION WITH THE BONDS.
- AGAINST       THIS IS A PROPERTY TAX INCREASE.

**11. ELECTION CODE.** In all respects said election shall be conducted in accordance with the Texas Election Code, except as modified by the Texas Education Code, the Texas Government Code, and the Federal Voting Rights Act of 1965, as amended, including particularly Chapter 272 of the Code pertaining to bilingual requirements.

**12. BILINGUAL ELECTION MATERIALS.** All election materials (including notice of the election, ballots, instruction cards, affidavits, and other forms which voters may be required to sign) and all early voting materials shall be printed in both English and Spanish, or Spanish translations thereof, and/or other assistance shall be provided, as required by the Texas Election Code and the Federal Voting Rights Act of 1965, each as amended.

**13. NOTICE.** Notice of said election shall be given by: (i) publishing a substantial copy of this Order, in both English and Spanish, one time at least ten (10) but not more than thirty (30) days prior to the Election Day in a newspaper of general circulation in the District, (ii) by posting, not later than the 21st day before the Election Day, a substantial copy of this Order, in both English and Spanish, on the bulletin board used for posting notices of meetings of the Board and in at least three (3) additional public places in the boundaries of the District, and (iii) by posting not later than the 21st day before the Election Day a copy of this Order, in English and Spanish, on the District's website, prominently and together with the Notice of Election and the contents of the Propositions, such Order to remain posted on the District's website through Election Day. In addition, on Election Day and during early voting by personal appearance, this Order shall be posted in a prominent location at each polling place. Notice of the Election shall also be provided to the County Clerk of Nueces County not later than the 60th day before Election Day; which notice each County is hereby authorized and directed to post to its website not later than the twenty-first (21st) day prior to the date set for the Election.

**14. DISTRICT'S OUTSTANDING DEBT.** As of the effective date of this Order, the District's aggregate principal amount of outstanding of tax-supported debt was \$754,580,929 and the aggregate amount of outstanding interest on such tax-supported debt was \$416,734,623.05. The District's total ad valorem rate for the current fiscal year was \$1.2405, which is comprised of a maintenance and operations tax rate component of \$0.9605 per \$100 of taxable assessed

valuation and a debt service tax rate of \$0.2800 per \$100 of assessed valuation of taxable property in the District. The District's taxable assessed valuation for calendar year 2021, as of the date that the current tax rate was established, was \$18,546,551,642.

**15. ISSUANCE OF NEW DEBT.** The District intends to issue the bonds authorized by the Propositions over a period of years in a manner and in accordance with a schedule to be determined by the Board based upon a number of factors, including, but not limited to, the then current needs of the District, demographic changes, prevailing market conditions, assessed valuations of property in the District and management of the District's short-term and long-term interest rate exposure. Market conditions, demographics and assessed valuations of property vary based upon a number of factors beyond the District's control, and therefore, the District cannot and does not guarantee a particular interest rate or tax rate associated with the bonds authorized by the Propositions. As such, the information contained in this paragraph is provided solely for illustrative purposes and does not establish any limitations or restrictions or create a contract with the voters. The District currently estimates that, if all of the bonds authorized by the Propositions were issued in accordance with the District's current project finance plan, the maximum interest rate on the unlimited tax bonds is not expected to exceed 5.00%.

**16. VOTER INFORMATION DOCUMENT.** The Board hereby approves a voter information document, in the form prescribed by Section 1252.052(b), Texas Government Code (the "Information Document") in substantially the form presented to the Board, with such changes as may be approved by the President or the Secretary of the Board, the Superintendent, or their designee, acting on behalf of the Board, in consultation with the District's chief financial officer, chief legal officer, bond counsel, and/or financial advisor, as prescribed by Section 1251.052(b), Texas Government Code

The President of the Board, the Superintendent of the District, or their designee, acting on behalf of the Board, is further authorized and directed to post or provide for the posting of the Voter Information Document in the same manner as provided for notice of the Election under Section 11 of this Order, and additionally on the District's website in an easily accessible manner beginning not later than the twenty-first (21st) day before the date set for the Election and ending on the day after Election Day.

**17. NECESSARY ACTIONS.** The President of the Board, Superintendent of the District or their designee, acting on behalf of the Board, in consultation with the District's attorney and bond counsel, is hereby authorized and directed (i) to take any and all actions necessary to comply with the provisions of the Election Code and the Federal Voting Rights Act in carrying out and conducting the Election, whether or not expressly authorized herein, including making changes or additions to polling places or procedures to the extent required or desirable as determined by the County Election Officers, or as may become necessary due to circumstances arising after the date of this Order, and (ii) to enter into agreements providing for joint elections with other entities and to make changes or additions to polling places and election procedures in the event changes are required because of such joint elections or become necessary due to circumstances arising after the date of this Order.

**18. JOINT ELECTION.** The Election shall be conducted as a joint election with other governmental entities ordering elections in the area of the District in Nueces County. The

Election Services Contracts providing for the joint elections and the conduct of the election by the Election Administrators shall be presented to the Board for consideration and approval. The Superintendent or his designee is authorized to amend or supplement the Election Services Contracts in order to conduct the Election in an efficient and legal manner.

**19. APPOINTMENT OF ELECTION ADMINISTRATORS.** The Elections Administrators of Nueces County are hereby appointed Election Administrators for the District and agent for the custodian of voted ballots in their respective jurisdictions.

**20. SEVERABILITY.** If any provision, section, subsection, sentence, clause or phrase of this Order, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void, invalid, or unenforceable, neither the remaining portions of this Order nor their application to other persons or sets of circumstances shall be affected thereby, it being the intent of the Board in adopting this Order that no portion hereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality, voidness, invalidity or unenforceability of any other portion hereof, and all provisions of this Order are declared to be severable for that purpose.

**21. CORRECTIONS.** The President or Secretary of the Board, the Superintendent, and/or the Chief Legal Counsel are hereby authorized and directed to approve any technical changes or corrections in the Order or to any of the instruments authorized by this Order necessary to (i) correct any ambiguity, mistake, or omission, or (ii) to comply with the requirements of the Texas Election Code or any other applicable law.

**22. EFFECTIVE DATE.** This Order shall take effect immediately upon its approval.
